





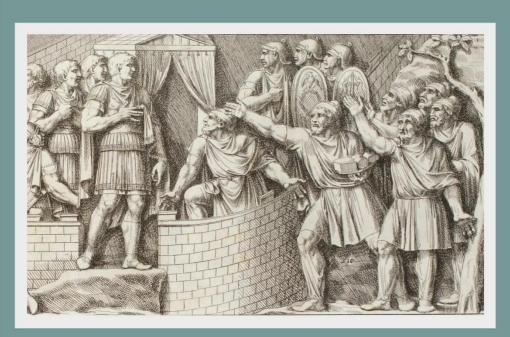

#### **ABSTRACTS**

# 3.1. The Activity Carried Out in Rome by Count Ignatius Batthyány (1741–1798), future Bishop of Transylvania. Contacts, Studies, and Research in the Vatican Archives and Other Libraries

Doina BIRO-HENDRE

The presentation follows the path of the student Ignatius Batthyány, from a magnate family that gave five bishops, one of whom became Primate of Esztergom and Cardinal, and also Blessed Ladislas Batthyany-Strattmann, beatified in 2003. He studied at the Collegium Germanicum et Hungaricum, where he prepared and defended his doctorate in theology and was ordained priest, in the presence of Pope Clement XIII, in the pontifical chapel. His expertise in diplomatics, codicology, and textology, acquired through research conducted in the libraries of Rome and in the Vatican archives—demonstrated by the texts he commented on and published—led to his admission as a member of the Philaletorum Society in Rome. From here, he carried to Eger and later to Alba Iulia the idea of founding a learned society that, by valorizing medieval documents, would restore the history of Transylvania and of the Hungarian Kingdom, as well as the history of the Church.

As bishop, he devoted himself to the organization of the diocese, the schools, and the astronomical institute, endowed with the precious Batthyaneum Library. As historian, he commented on and published the 11th-century treatise of the first Bishop of Cenad, Gerardus, as well as the collection of synods, in three volumes, based on documents copied in Rome by himself and by the librarian he had sent to Italy for this very purpose.

# 5.2. The Repatriation of the Dacian Royal Treasures and the *Lex Troesmensium* Tablets: Romanian–Italian Judicial Cooperation

Augustin LAZAR

This paper offers a concise overview of the case law that established the legal precedent for the recovery of the Dacian gold bracelets, identified as numbers 1 to 14, stolen from the UNESCO World Heritage site of Sarmizegetusa Regia. It sequentially presents the batches of repatriated artifacts, which form part of the Dacian treasures illicitly removed and currently classified as "treasure" within Romania's National Cultural Heritage.

The paper highlights the focus on the recovery of cultural property and the legal instruments employed in this process, including amicable civil settlements with good-faith possessors (providing just compensation: the purchase price and restitution costs, as per Article 4 of the UNIDROIT Convention, 1995), Directive 2014/60/EU of 15 May 2014 on the return of cultural objects unlawfully removed from the territory of a Member State, as well as international judicial cooperation mechanisms (national criminal legislation, asset freezing orders, and European Investigation Orders).

Key tools for authentication were expert reports that applied advanced digital technologies. These forensic assessments highlighted emblematic features of the recovered items: stylistic and technical characteristics, weight, composition, market value, insured value (for theft or destruction), and their link to the archaeological context of origin.

Furthermore, the paper reveals the fraudulent mechanisms uncovered, used to **launder and recycle** the artifacts in order to obscure or conceal their criminal provenance. These included presenting the artifacts as originating from a broader cultural region, claiming them as the legitimate property of deceased reputable individuals (e.g., professors, aristocrats), as items from lawful collections, or using them as collateral in civil contracts.

Defendants also concealed the illicit origin of the objects through false customs declarations—for instance, stating that a bracelet had been legally imported into the United States from Albania. Data obtained from eBay Inc. revealed that the defendants' email addresses were linked to anonymous user accounts—such as the account "domprofesor" on www.ebay.com—through which stolen artifacts were trafficked under the guise of a reputable anonymous dealer.

# 6.2. The Dacian Royal Gold Bracelet Treasures from Sarmizegetusa Regia: The Recent Repatriation of Bracelet No. 14

## Ernest OBERLÄNDER-TÂRNOVEANU

At the end of October 2024, the National Museum of Romanian History received into its custody the fourteenth Dacian royal gold bracelet, recovered by judicial authorities in Timişoara. The artifact is a multi-spiral bracelet with five coils (three complete and two partial), weighing 1286.7 grams and measuring 181.5 cm in its unfolded length. The terminal plates are decorated with protomes of winged dragons and seven stamped palmettes each—ornamental motifs characteristic of the royal gold bracelets from Sarmizegetusa Regia.

Physico-chemical analyses performed at the Horia Hulubei National Institute for Physics and Nuclear Engineering confirmed that the bracelet was crafted from a natural alloy composed of 87.6% gold, 11.23% silver, and 0.89% copper, corresponding to native Transylvanian gold

originating from the so-called "Golden Quadrilateral." Deposits of copper compounds and traces of tin, iron, and nickel indicate prolonged burial alongside silver artifacts—possibly Dacian Koson coins—within a ritual deposition context.

Stylistic and technological expertise demonstrated that the bracelet was produced in the same workshop at Sarmizegetusa Regia as bracelets nos. 4, 9, and 13, based on the identification of the same punch (type A3d) and identical manufacturing techniques, namely cold hammering, punching, and engraving with wooden and metal tools.

Through its formal, technological, and decorative features, bracelet no. 14 clearly belongs to the series of Dacian royal gold bracelets dated between 44–30 BCE, confirming both the authenticity and stylistic coherence of the Dacian goldsmiths' craftsmanship from Sarmizegetusa Regia, the pre-Roman capital of Dacia.

# 7.2. The "Spontaneous" Repatriation of the 14th Dacian Royal Bracelet from the UNESCO Site of Sarmizegetusa Regia

The repatriation of the 14th Dacian royal bracelet, looted from the Orăștie Mountains area, illegally exported, and subsequently sold to a foreign citizen in 2024, resulted from an unprecedented investigative operation. The action was coordinated by a public prosecutor and carried out by specialized officers of the Criminal Investigation Bureau within the Timiş County Police. Capitalizing on a tactically favorable moment, the investigators secured the cooperation of the artifact's possessor, which ultimately led to its "spontaneous" repatriation.

The ex officio case file, initiated in June 2024, led to the official transfer of the spiral bracelet no. 14 into the custody of the National History Museum of Romania in Bucharest on October 21, 2024—approximately 13 years after the last bracelet was recovered. An expert confirmed the authenticity of the artifact, weighing 1,286.70 grams, as part of the Dacian royal hoard of spiral gold bracelets looted from the Sarmizegetusa Regia archaeological site and listed in the OIPC-INTERPOL alerts. This recent repatriation highlights once again the judicial relevance of the mechanisms employed by organized crime networks in the theft, trafficking, and laundering of cultural artifacts. These mechanisms typically begin with unauthorized detection and excavation, followed by theft, illegal export, and the sale of artifacts presented as licit goods, all aimed at concealing or disguising their criminal origin.

## 8.2. Recovering of the past. A new successful case concering the national cultural heritage of Romania

In 2024, after efforts that lasted more than 5 years, the Romanian authorities succeeded in recovering a set of three prehistoric gold bracelets. Initially identified at an auction house in Monaco, they were later repatriated from Belgium. The objects had left Romanian territory illegally. The three prehistoric ornaments are highly decorated, with similar shapes and design, most likely made by the same prehistoric goldsmith. The three prehistoric gold artifacts date from the end of the Bronze Age (late Bronze Age) and the beginning of the Early Iron Age, around 1150 BC, meaning they are over 3,000 years old, dating back to the end of the 2nd millennium BC. Legally categorized as movable goods of the national cultural heritage, at the beginning of this year, they are currently held in the collections of the National Museum of Romanian History, in temporary custody until the completion of legal procedures.

# 9.2. XRF-Based Authentication of a Koson Coin Hoard Recovered from Online Sales and Its Attribution to the Archaeological Context of Muncel – Fagii lui Bodea, Pit No. 11

Victor Emanuel PETAC

The recent recovery of two Koson-type staters, one without monogram (the pair of dies Obv. 10 / Rv. 3) and the second with monogram (corresponding to the pair of dies Obv. 5 / Rv. 2) has led to concern about their attribution to a specific context. Based on the analysis of the structure of the pairs of dies of the lots recovered so far, we were able to establish that the first pair of dies (Obv. 10 / Rv. 3) is found in a proportion of about 20% in the lots recovered and now at the National Museum of History of Romania, being completely non-specific to the hoard generically called "from Târsa", where there are no pieces without monogram. Regarding the second pair of dies (Obv. 5 / Rv. 2, the monogrammed stater) the share is relatively equal in the lots at the National Museum of History of Romania (a little over 4%) and somewhat higher in the "Târsa" gold lot (around 7%), being therefore less conclusive, but ensuring in any case the provenance from the poached lots from Sarmizegetusa. The XRF analyses performed generate additional data. Thus, the piece without monogram stands out for its very low gold content, around 73%, which places it exclusively in the so-called "from the fox's den" lot, also located at the National Museum of History. Regarding the monogrammed stater (pair Obv. 5 / Rv. 2) it has a gold content of around 86%, corresponding to the last staters minted with that pair of dies. Everything indicates belonging to the lower quality batches, selected as such by poachers. Keywords: Koson-type staters; National Museum of History of Romania; Târsa hoard; Sarmizegetusa Regia.

## 10.2. Judicial Cooperation for the Recovery of a Koson Gold Coin Hoard from an Auction House in Turin

The paper provides a concise overview of the main instruments of international judicial cooperation applied during the criminal investigation stage, focusing on their efficiency and practical implementation within recent judicial practice. It examines and compares three key legal instruments: the European Investigation Order, established under Directive 2014/41/EU; the Freezing and Confiscation Orders, governed by Regulation (EU) 2018/1805; and the Joint Investigation Teams, created pursuant to Framework Decision 2002/475/JHA.

The theoretical analysis is complemented by relevant case studies that highlight the successful outcomes of international cooperation in recovering cultural assets. Notably, the study presents the 2015 recovery of two Koson gold coins sold at auctions in Warsaw and Poznań, as well as the 2014 recovery of a lot of 27 Koson gold coins offered for sale by an auction house in Turin, Italy. These examples demonstrate the practical value of international judicial cooperation in safeguarding cultural heritage and combating cross-border crime.

# 11.2. Sarmizegetusa Regia and Trajan's Column. The archaeological and sculptural image of the Dacian wars

The first association of the ruins at Grădiștea de Munte (Sarmizegetusa Regia) with Trajan's Column dates back to the early 19th century. One of the Transylvanian scholars of the time, Abbot Eder, correlated the report of the discovery of an ancient settlement somewhere in the mountains with the scenes on the Column and concluded that Grădiște could be the location of the last capital of King Decebalus.

In the following two centuries, archaeological information about Sarmizegetusa Regia multiplied, including that the "great fortress" was the epicentre of the Dacian-Roman confrontations from the

beginning of the 2nd century AD. At the same time, historiography recorded numerous attempts to corroborate archaeological data, ancient written sources and images carved in marble in the centre

of Rome in order to better understand the dynamics of the wars between Decebalus and Trajan, the architecture of some constructions at Sarmizegetusa Regia or to recognise on the Column a series of ancient objects, today artefacts with extraordinary cultural value.

After a review of previous efforts, the presentation brings to the fore the new archaeological discoveries at Sarmizegetusa Regia that evoke the ancient wars, following, as much as possible, the narrative offered by the Column. The presentation has an interactive part, the Dacian and Roman vestiges from Grădişte, as they were revealed through archaeological research, being documented with the help of new technologies.

### 13.2. Constitutionality aspects in the field of the national cultural heritage protection

This paper deals with the problem of constitutional landmarks for legal protection of the national cultural heritage. Starting from the consecration of access to culture as a fundamental right, it is highlighted the establishment by the Constitution of the state obligation to ensure the support of national culture, protection and preservation of cultural heritage, free participation in the country's cultural life and promotion of Romania's cultural values.

About fulfilling the mentioned constitutional duty, it is observed the need to achieve an adequate normative framework, which primarily respects the principles of state powers separation and non-discrimination, basic requirement for the proper functioning of this social life sector.

The study highlights the fact that, although the legislative power has a certain margin of appreciation in its legislative activity, the drafting of the law must be within the limits established by the Fundamental Law. In this context, the main issues of unconstitutionality brought to the attention of the Constitutional Court in the legislative process occasioned by the intention to regulate the legal situation of Peleş Castle, an asset that belonged to the former sovereign of Romania, Michael I, are identified.

# 16.3. Revolution and Cultural Heritage: Damage to Heritage Assets during the December 1989 Romanian Revolution

The Romanian Revolution of 1989 marked the liberation of the Romanian nation from Ceauşescu's dictatorial regime, representing a collective act of courage and a decisive moment in which the people chose to reject an oppressive and absurd system that had kept them in captivity. Unfortunately, the political and military powers that assumed control in the aftermath initiated a vast

disinformation campaign, which resulted in the deaths and serious injuries of many innocent civilians. Additionally, the revolution led to extensive damage to the country's cultural heritage: over 500,000 valuable books were completely destroyed by fire, including 12,000 rare and collectible volumes. Many rare maps were also lost, alongside more than 3,700 manuscripts belonging to prominent Romanian cultural figures, as well as numerous highly valuable paintings.

The Revolution of December 1989 represents a defining moment in Romania's transition toward democracy, marked not only by profound political and social change but also by significant cultural losses. Amid the chaos of armed confrontations, numerous monuments, historic buildings, and cultural institutions were severely damaged or destroyed, among them the Central University Library and the National Museum of Art in Bucharest. Cultural heritage, as a symbol of national identity and collective memory, suffered greatly in a context where its protection was not a priority.

This tragic episode underscores the fragility of cultural values in the face of violence and highlights the urgent need for coherent and effective policies aimed at safeguarding historical heritage, even in times of crisis and social upheaval.

# 18.3. Concrete Utopia in the CeauŞescu Era: Demolitions and Dictatorship. Documentation of the Fires at the Art Museum and the Central University Library 'Carol I' in the Carol I University Foundation Palace, Seat of the Royal Foundations;

During the dictatorship of Nicolae Ceauşescu, one-fifth of the surface area of Bucharest, the capital of Romania, was demolished on the orders of the "nation's first architect," equivalent to the surface area of Venice.

No state, ever in its history, has suffered losses like those caused by the famous Ceauşist systematization plan, which led to the disappearance of over 40,000 structures—homes, administrative buildings, monuments of art and culture, monasteries, and churches. Churches,

statues, or symbolic buildings of exceptional value and historical significance. All of them fell before communism. The demolitions began after the 1977 earthquake. Nicolae Ceauşescu ordered the destruction of 20 places of worship, most of them in the category of historical monuments.

There was a strong reaction from the Commission for Historical Monuments, and in response, Ceauşescu dissolved the Commission. There were successful initiatives that managed to save a few of the history-laden churches from the bulldozer's blade. Engineer Eugen Iordăchescu is the one who coordinated the moving of eight churches in the capital, out of the 11 whose locations were changed.

## 19.3. Criminal Protection of Natural Heritage as Part of the National Cultural Heritage in the Context of Directive 1203/2024 on the Protection of the Environment through Criminal Law

Remus JURJ Vasile DRĂGHICI

This paper develops and refines arguments initially presented by the authors at the *International Conference PATRIMONIUM VI* (May 19–20, 2022), focusing on the evolution of Romanian and European legal frameworks concerning the protection of natural heritage. The initial proposal sought to extend the application of Article 253 (1) and (3) of the Romanian Criminal Code to cases involving the destruction of ancient or emblematic trees, regardless of their location in urban or protected natural areas.

Subsequent legislative developments reinforced this approach. Law No. 97/2023 introduced a formal legal definition of ancient trees, while the *New Forestry Code of 2025* (Law No. 331/2024) recognized such trees as elements of ecosystems with high conservation value. The Code increased criminal penalties by 50% for acts of destruction, theft, or illegal logging within these ecosystems. The paper includes a comparative analysis with Italian legislation and doctrine, where cultural heritage is viewed as part of a broader concept of the environment, encompassing both natural and human-made elements. Italian Law No. 238/2022 further integrated biodiversity and ecosystems as the third pillar of cultural and environmental protection.

Directive (EU) 1203/2024 is examined as a cornerstone of European environmental criminal law, requiring Member States to criminalize conduct causing serious harm to people, ecosystems, or environmental quality. It also mandates increased penalties—up to 3–5% of global annual turnover or €24–40 million—for legal entities. Article 20 strengthens judicial cooperation across borders.

In conclusion, Directive 1203/2024 consolidates the protection of natural heritage as an intrinsic component of the broader European concept of cultural heritage.

The Government and the administrative-territorial units have, according to the law, a right of preemption in the purchase of real estate properties possessing cultural or historical value. Failure to observe this right results in the absolute nullity of the sale.

However, judicial practice is markedly inconsistent in determining the existence of this civil sanction in cases of non-compliant sales.

The authors seek to identify the reasons for this apparent judicial chaos, which has major implications for the civil circulation of real estate, while also noting the inadequacy of regulating absolute nullity in such situations and proposing practical solutions.

# 22.3. Judicial Instruments Concerning Romania in the Field of International Cooperation for the Protection of Cultural Heritage: The Applicability of the 1954 Hague Convention and the 1995 UNIDROIT Convention

The practical application of the Hague Convention (1970) and the UNIDROIT Convention (1995) implies a complementarity in the reaction of the authorities to the illicit trafficking of cultural heritage goods of the states. The Hague Convention provides legal support for export prevention activities and for administrative cooperation between the states, and the UNIDROIT Convention strengthens the mechanisms for the recovery and restitution through judicial means of stolen or illegally sold goods.

Thus, in practice, the states use the Hague Convention to notify and block the unauthorized movement of heritage, and the provisions of the UNIDROIT Convention are used by the courts for the rapid recovery of stolen or exported goods, ensuring restitution to the legitimate owners and strengthening international cooperation in judicial and extrajudicial proceedings.

Furthermore, it integrates a comprehensive review of the jurisprudence of the European Court of Human Rights (ECtHR), the Court of Justice of the European Union (CJEU), and UNESCO's doctrinal instruments, aiming to delineate efficient and coherent legal mechanisms capable of ensuring effective reparation and deterrence of eco-cultural damage.

In its concluding section, the paper advances a series of de lege ferenda proposals, substantiated by EU directives, strategic policy documents, and international conventions, intended to consolidate a

unified and preventive framework for the protection and restoration of biodiversity endowed with cultural value.

The research thereby contributes to the conceptual and practical development of the emerging doctrine of eco-cultural liability, promoting an integrated juridical approach to the protection of both natural and cultural heritage.

# 25.4. Preventing crimes against cultural heritage in the Republic of Moldova: legal and institutional perspectives

# 26.4. Open-Source Information Used in the Investigation of Crimes Against National Cultural Heritage

The paper examines the role of open-source information in investigating crimes that affect national cultural heritage, ranging from archaeological looting and museum thefts to forgery, money laundering, and corruption. It analyzes the tools employed at both international and national levels (Interpol – Stolen Works of Art Database, ID-Art, NSAF, Leonardo, the Art Loss Register, and the Romanian Police "Stolen Objects" application), with a focus on their contribution to the identification and recovery of cultural assets. The comparative study highlights the limits of interoperability, the solutions proposed through the European RITHMS project, as well as institutional best practices at the international level.

In conclusion, the paper underlines the necessity of integrating open sources of information, strengthening specialized structures, and harmonizing legislation through international cooperation frameworks and partnerships with academia and the private sector, in order to ensure the protection and transmission of cultural heritage to future generations.

## 27.4. Lost treasures? Analysis of the international auction market for Koson and Koson-Droyeis issues over the past year

Claudiu PURDEA

The primary objective of our presentation is the cataloguing of Koson and Koson-Droyeis coin issues offered for sale through public auctions over the past year. An equally relevant aspect of our analysis concerns the declared provenance of these artifacts. Building upon the inventory published in 1912 by Baron Max Ferdinand von Bahrfeld, as well as the assessment provided by Barbarra Deppert-Lippitz in 2013—both considered key reference points in the scholarly investigation of this subject—we observe a significant increase in market activity for such items beginning in 1993. This development is further substantiated by the expert evaluation of Dr. Ernest Oberländer-Târnoveanu, who confirms that the introduction of 95 gold Koson coins into the antiquities market in 1993, nearly half of which lack a monogram, serves as evidence for the discovery of a hoard in the Orăștie Mountains. These findings have prompted us to examine the international auction

market in greater detail, transforming this topic, under the supervision of Professor Augustin Lazăr, into a distinct line of research. As a result, our survey of public sales from the past year has identified 100 gold and 26 silver issues, seven of which bear the Koson-Droyeis legend.

But is "obștea" or "composesoratul" an outdated, obsolete institution and should a change in legal regime be prepared for it?

# 30.4. The Episcopal Palace of Alba Iulia: Functional and Structural Transformations and Ecclesiastical Patrimony in the 18th Century. Preliminary study

The presentation focuses on a document dated 1780, which constitutes the inventory of movable and immovable goods transferred by Bishop Ladislaus (László) von Kollonitz to his successor, Ignatius Batthyány, at the conclusion of his administration of the Bishopric of Transylvania. The inventory provides a detailed description of the furniture, utilitarian objects, and decorative items from the episcopal residence in Karlsburg (Alba Iulia), reflecting the tastes, organization, and aesthetic concerns of the ecclesiastical elite of the period. Analyzing this document allows not only the reconstruction of the material heritage of the bishopric but also an understanding of how the transfer of goods and administrative responsibilities between bishops was managed.

# 31.4. Management of a European-Level Investment in an Archaeological Site The Vauban-Type Bastion Fortress of Alba Iulia

The Alba Carolina Vauban-type bastion fortress in Alba Iulia has been cited as an exemplary case of excellence in the use of non-reimbursable European funds under the 2007–2013 budgetary framework, financed through the European Regional Development Fund, within the objective of promoting social inclusion and combating poverty.

The total investment of €44,600,000, of which €37,878,000 were non-reimbursable funds from the European Union (EU), represented a strategic investment for the future, made possible by the favorable political and economic context created by Romania's accession to the EU.

Alba Iulia did not settle for the fixed sum allocated to county capitals but dared to dream ahead, anticipating future European funding opportunities. The result was spectacular: the city managed to secure over €200 million in European funds, becoming—with more than €3,000 per inhabitant—the Romanian municipality that accessed the highest amount of European funding.

The strategic vision "History Has a Future" bestowed upon this millennial city—also known as The Other Capital of Romania—a renewed brilliance of destiny.

The restoration of the Alba Carolina Fortress, built on the site of the former Roman castrum of the Legio XIII Gemina, was a decisive measure that enabled the professional reconversion of local residents who had lost their jobs following the dismantling of industrial units during the communist period.

Today, the fortress has been transformed into a vast open platform—a stage hosting economic, cultural, and administrative activities.
